OPERATIONS AND COVID-19

Vendor Guide



Are you feeling sick? Have you been around someone who has tested positive for COVID-19? **PLEASE STAY HOME!** 

- Keep customers and products separated by placing the products behind you.
- Coronaviruses can survive on metal, glass and plastic for as long as 72 hours. Be sure and sanitize regularly.
- A bleach solution can be used to disinfect surfaces. Use the ratio of 1/3 cup of bleach to o ne gallon of water.

## **Sanitation Checklist**

Sanitize your hands before and after every interaction and transaction, even if you are wearing gloves!



- Clean any tables, products or signs that will be on display.
- Frequently disinfect all metal, glass and plastic surfaces that you, or your customers touch, at least once an hour and at the end of the day.
- Sanitize hands thoroughly after using the restroom, coughing or sneezing.
- Use a paper towel to touch any handwashing stations or sanitizer pumps.
- Avoid touching your face, nose or cell phone.

## **Customer Interactions**

- Pay attention to signage and follow instructions.
- Keep conversations to a minimum.
- No touching, shaking hands, hugging, or any other personal contact (even friends or family).
- Remind customers to keep at least six feet of space between them.
- Customers should avoid all contact with products.
