



## Automotive Club Entry: Car clubs | single vehicles | Antique vehicles (car, bus, truck, tractor) Entry Fee: \$35

- Entries may consist of no more than 12 automobiles
- Entries MUST ride two abreast during the ENTIRE parade route
- Clubs will be accepted on a first come, first served basis with a limit of six clubs total
- Single auto units (i.e. historical autos) will be limited to 8 and will ride together as a unit. Units will be accepted on first come, first served basis.
- Unlawful or dangerous use of motorized vehicles is strictly prohibited and will result in immediate withdrawal from the parade

#### **Equine Entry:**

#### Entry Fee: \$35

- Please make us aware of your needs, requirements and limitations of your unit so that the animals will not be harmed and will be safe for the parade attendees.
- Each unit is responsible for their own manure removal from assembly area through the entire parade route.
- Each unit must have a pooper scooper behind their unit with the capacity to hold manure for the entire parade route.
- Only experienced parade animals will be permitted to participate. Any animal not under control will be removed from the parade
- The parade route is approximately 1 1/2 miles, on asphalt

#### **Elected Officials Entry: Only SITTING, ELECTED officials are eligible to participate.**

### Entry Fee: \$200

- Entries may consist of no more than one vehicle and two walkers
- Signage stating "Re-Elect" or "Vote For", etc. will not be allowed this includes t-shirts.
- No election materials, shirts or swag are permitted.
