PREFACE

Introduction:

The Jeffersontown Chamber is proud to produce the inaugural printed edition of a Jtown City Council forum.

Since the Jeffersontown Chamber is focused on business and economic issues, this publication is meant to offer each candidate an opportunity to share their views on important topics that impact the Jeffersontown economy and its workforce.

Quick Overview of Process:

- There are 16 candidates running for Jtown's eight council seats including the current eight council members.
- All candidates were invited and had approximately 20 days to respond.
- The answers are published exactly as they were submitted in printed format. The only editing that has been done is as it relates to spacing and margins.
- On November 5, voters will choose from the list of 16 candidates and the eight candidates with the most votes win the election.
- Candidates are presented in this document in alphabetical order by last name

Jeffersontown's Government Structure:

- Jeffersontown has a mayor-council form of government.
- The mayor is elected every four years and may serve three terms.
- The mayor serves as the executive branch of government.
- City council members are elected every two years with no term limits.
- The city council serves as the legislative branch of government.
- The mayor and city council members receive a salary/benefits as do city employees per KRS 83A.070.
- The city council may enact ordinances; levy taxes; adopt a budget; and set compensation along with other duties and responsibilities.

Since 2011, I have focused my time on the city council around four main pillars: government transparency, fiscal responsibility, advocacy for infrastructure improvements, & encouraging economic development. In regards to transparency, one of my first accomplishments was establishing the live-streaming, recording, and storage of the city council meetings for public viewing. I also actively keep the public informed and engaged about city events, topics, & issues. With fiscal responsibility, I routinely speak up during the budget process, and I am proud that the city has passed balanced budgets with strong city services, and we have done so without raising taxes. We have also improved the city's infrastructure through our streetscape projects, additional parking options along Watterson Trail & Taylorsville Road, additional sidewalks, renovations to Veterans Memorial Park, the new police department building and the upcoming amphitheater. I was also able to enhance our already business-friendly environment through the creation of the Jeffersontown Occupation Business Savings (J.O.B.S.) Program, by encouraging common sense rezoning, and my frequent support of the Jeffersontown Chamber. All of these efforts have played a role to help promote the growth you see in Jeffersontown today.

On a personal note, I love cooking each day for my family which includes my wife Kristen, our 3 awesome kids, and our pug Lucy.

What is your vision for our community?

I love Jeffersontown. It's where I was born and raised, and where my wife & I are raising our family. I am lucky to have grown up here. The city leaders that came before me were able to lay down the foundation and add to the great amenities our city has today. I am grateful for their work, and I too, am committed to building a strong and prosperous city, not just for my family, but for all Jeffersontown residents and future generations.

The development of the amphitheater has faced delays extending beyond the original intended timeline. How do you plan to expedite the completion of this project and ensure the successful launch of programming?

When our new Mayor took office last year, she successfully prioritized the completion of the new police department building over the completion of the amphitheater project. In the fall of last year, I worked with her, her administration, and the other members of the city council to secure funds to allow for the amphitheater to open in 2025. An amphitheater project manager was added, and in the most recent project phase, we added penalties if certain completion deadlines aren't met. These additional enhancements will allow for this phase to have the facility ready for the 2025 Summer Season. As a council member, I will continue to monitor its progress by working with our mayor, her administration, and other members of the city council to ensure its timely completion.

As housing development grows in and around Jeffersontown, traffic in the area seems to be getting more congested. How will you address the growing traffic concerns and help to mitigate it? There are two ways to address increased traffic in Jeffersontown. The first way is to increase available routes through our city by connecting existing streets that allow traffic to get through our town and by improving existing alleys and extending corridors that allow easier access to different points of interest. The second way to help with this issue is to provide more options for parking, like the roughly 50 additional spots that will be available in our Gaslight District when the new police department building is complete, and by creating more off-street options like additional bike & pedestrian corridors that better connect our neighborhoods to our commerce areas.

TARC is currently facing a serious financial crisis which could threaten transit services in Jeffersontown. Changes to TARC services in Jtown impacts both residents and employers. Transportation is the number one reason someone loses a job. What steps will you take to help retain this bus service and/or provide alternative transit in Jeffersontown?

While some of our residents and businesses do benefit from TARC services, it's important to keep in mind that the City of Jeffersontown does not fund TARC or have oversight into their expenses. TARC receives a majority of their funding (roughly 60%) from the Mass Transit Fund, while 19% comes from the federal government, 15% from TARC riders, and 6% from a combination of state funding, special fares, advertising revenue and additional minor funding sources. The Mass Transit Fund is an earmark in Louisville Metro's occupational tax that anyone who works in Jefferson County pays. Therefore, J-town residents are already funding TARC through Louisville Metro's occupational tax, even if they don't use TARC's services. As a council member, it is important to be fiscally responsible with our taxpayers' money, and that's why I would oppose any attempt to add additional funds directly from our city government (the J-town tax payers) to TARC, especially since they have already announced route reductions for Jeffersontown. A more likely solution would be to increase Mass Transit Fund revenue, Louisville Metro's government can reconfigure the distribution rates within their occupational tax. The Mass Transit Fund can be changed from 0.2% to 0.4% and in order to not raise the overall occupational tax rate, Louisville Metro's distribution can be changed from 1.25% to 1.23%

I am focused on getting a positive outcome, so I have also made myself available to meet with Louisville Metro representatives about their distribution rates and with TARC representatives to help find a way to decrease their expenses.

The Jeffersontown Gaslight Square is an iconic center for gatherings and commerce. What is your vision for downtown Jeffersontown?

I see a future Historic Gaslight Square District that is even more vibrant and more bustling with people and commerce than there is today. I believe that I can help achieve this by advocating for continued infrastructure improvements, creating better connectivity between people and businesses, and growing a stronger partnership within the business community and with the city.

While serving on the city council, I have been able to actively participate in all of these areas. We have improved our infrastructure through our streetscape projects, the relocation of powerlines along Watterson Trail, & by creating additional parking options throughout the district. Roughly 50 more parking spots will become available after the new police department building is complete and we have also identified a few other locations within the district for parking options. While some connectivity improvements were made through the streetscape projects, I would like to see additional sidewalks or bike & pedestrian corridors along the curve of Billtown Road and along both sides of Ruckriegel Parkway. I think we should also connect roads, like Billtown Road to Eastview and Shelby Street to Taylorville Road, to allow traffic to flow more freely and ease congestion. Lastly, we need to build upon the synergy within the district by building on our partnership with the business community. Outside of continuing to host major city events within the district (Gaslight Festival, Pumpkinfest, & Christmas at Gaslight Square), we need to continue the smaller spotlight type events like the morning and evening farmers market & the trolley hop. I am also excited about the recent kick-off of Envision Jeffersontown. It is the formation of a group of business leaders within the Historic Gaslight Square District who work together to promote the area, strengthen the relationship between businesses, and build upon the partnership with the city. If I'm re-elected, I would like to continue working on these initiatives and see the district become a place that is a year-round destination location for the rest of Jefferson County.

The Bluegrass Commerce Park is a vital part of Jtown's economy. It is home to more than 1,000 businesses including Baptist Health, ADP, KCC, and many others (large and small). As a councilperson, what will you do to support employers and help grow the Jtown economy? As mentioned in my bio, encouraging economic development is one of the four pillars that I have focused on during my time as city council member. I have a strong track record of supporting our employers and helping the J-town economy grow over the years. I was instrumental in creating the J.O.B.S. Program which provides economic incentives over a five-year period when a business creates 3 or more jobs that meet a new combined annual payroll requirement. We saved employers time by creating our own Board of Zoning Adjustment, which helps businesses streamline certain aspects within the zoning process by allowing them to work with the City of Jeffersontown instead of having to accommodate to Louisville Metro's schedule. I've always advocated for infrastructure improvements that are both functional and cosmetically pleasing, leading to business attraction and retention. Having strong public safety also helps our economy flourish and I'm proud of my record supporting our police department. I am especially excited to work with our mayor and her administration to lobby the Kentucky General Assembly to remove the stacking of occupational taxes (Metro's 2.2% + J-town's 1.0%) that are unfairly is applied to all workers within our city limits. If re-elected, I will continue these types of activities which all lead to helping our J-town economy grow.

As Jeffersontown has no authority over TARC, there is very little we can do to affect how the program operates. We can, however, look at ways to compliment the TARC system here in Jeffersontown for our residents—perhaps a shuttle or bus program centered in Jeffersontown in order to bridge the gaps left by a failing TARC system. Also, we should always strive to be more strategic with our economic development, we need to ensure that all businesses in Jeffersontown are encouraged to hire residents who live in Jeffersontown. Keeping the jobs local removes the strain of long-distance travel to find work.

The Jeffersontown Gaslight Square is an iconic center for gatherings and commerce. What is your vision for downtown Jeffersontown?

The Gaslight Square has seemed like an afterthought for many years now. If we truly want this to be our downtown and city center, we need to prioritize it. I would work with our local government to find ways to make our city center a place for all of the residents in our community to socialize and mingle. The best thing about Jeffersontown is our community. The more opportunities we have to get together and bond, the better.

My vision for Jeffersontown, since having been appointed to the council, has been one of working with Mayor Pike and my fellow council members to strengthen our community through economic growth. Bringing good paying jobs to our city will allow our residents to work closer to their homes and families. This will also create a tax base with which our residents can enjoy a great quality of life. This includes one of the lowest property tax rates in the commonwealth, great parks, garbage collection, a public works that responds to weather related issues and a professional police department to keep our city safe.

The development of the amphitheater has faced delays extending beyond the original intended timeline. How do you plan to expedite the completion of this project and ensure the successful launch of programming?

In early September, I and other members of the city council approved a resolution allowing Mayor Pike to execute a contract involving phase two of this project. This contract, that was negotiated by Mayor Pike and her administration, sets timelines and penalties that will be enforced if the agreed upon timelines are not met.

I am excited for our citizens to see the progress at the amphitheater as the city works with a new company to bring about the phase two completion.

As housing development grows in and around Jeffersontown, traffic in the area seems to be getting more congested. How will you address the growing traffic concerns and help to mitigate it?

I will work with our representatives on the state and local level since most of our congested roads are maintained by the state of Kentucky or Louisville Metro Government. This will include issues of turn lanes, traffic lights etc.

I will also work with fellow members of the city council to adopt and approve zoning that works towards preventing congested roads in our community.

TARC is currently facing a serious financial crisis which could threaten transit services in Jeffersontown. Changes to TARC services in Jtown impacts both residents and employers. Transportation is the number one reason someone loses a job. What steps will you take to help retain this bus service and/or provide alternative transit in Jeffersontown?

At this time, I would need to see TARC get its financial house in order before I would agree to future funding. The agency has been responsible for paying out millions of dollars in accident claims and harassment allegations against a former director along with other mismanagement.

I cannot see our taxpayers' hard-earned dollars going to fund an agency that has in the past not corrected problems they were aware of. I would be willing to look at working with TARC if they create a plan that addresses my, and citizens', concerns.

I would want guarantees that not only would past issues be corrected but also assurance that Jeffersontown would be getting the appropriate amount services that we pay for.

I want to see a continuing growth of businesses making Gaslight Square their home. I will continue to work with fellow council members, Mayor Pike, and the Chamber of Commerce to recruit and support our local business owners.

What is your vision for our community?

I am running for city council to support the amazing community we have in Jeffersontown and facilitate our growth into the future. With the growing number of young families making Jeffersontown home, I want to ensure they have a connection to the council and know how the city works so they can be actively involved. I already show up for Jeffersontown at community events and that will only continue when I am in office. I would also plan to host community meet-ups to hear directly from residents and be accessible to them as a councilwoman.

Part of what I love about Jeffersontown is that while we are a top 20 city in Kentucky in terms of population, and now part of Louisville Metro, we have maintained our sense of a community that knows and cares about each other. As we continue to grow, I want to ensure we maintain the small town energy that makes this community great and support new folks moving to Jeffersontown and joining this community. Connecting us with the advances in technology is an important way of how we do this. We already have council meetings streamed online, and I would work with the council to make it even easier for the community to know issues that are being discussed and provide input, because an engaged community is a connected community.

The development of the amphitheater has faced delays extending beyond the original intended timeline. How do you plan to expedite the completion of this project and ensure the successful launch of programming?

Our Mayor has already done a great job of identifying issues and bringing in additional help to support this project. What I would do personally, if elected, is visit the site once a week or every two weeks to keep tabs on what is going on. I would interact with the project manager and those involved in completion to see where the project is and what, if any issues, are being encountered. If there are continued issues or delays, I would engage with the Mayor and the council on what we can do to help mitigate the challenges. I would also communicate about the progress of the amphitheater with the community as there might be people in our community who could serve as further assets to complete this quickly.

To ensure a successful launch of programming I would work with the Chamber and local businesses to ensure we have a great programming calendar. I believe that with the right events and marketing, we can make the amphitheater a destination for folks from across Jeffersontown as well as Louisville Metro. I would attend all the programming I could and encourage others in my network to go. While there have been several setbacks to the progress of the amphitheater, I would do everything in my power to make it a successful space for the city moving forward.

As housing development grows in and around Jeffersontown, traffic in the area seems to be getting more congested. How will you address the growing traffic concerns and help to mitigate it?

If elected, two items that I would focus on are traffic lights and patterns. A continued review of potential improvements will help ensure we adjust as our city grows. Another way to address current issues is to work to encourage other modes of transportation, especially for folks who live in Jeffersontown. This would mean looking at our walkability and bikeability throughout the town. If someone is going somewhere for dinner, it would be great if they felt safe to bike or walk the distance instead of needing to take a car if they wanted. I would also partner with the Jeffersontown police and harness connections I have with Metro and state officials to address potential solutions that might extend beyond the purview of city council.

I will also be a voice to ensure that new developments have proper traffic consideration in their plans, and that results of all traffic studies are easily accessible to the public. We can guide development by ensuring that, especially for new multi unit developments, thought has been given to ingress and regress options and roads are capable of handling the new traffic. I would push to ensure there are good plans for a new development before voting to approve it. Growth is normally far from perfect, but we can learn from challenges and work to improve with each new step.

Transportation is the number one reason someone loses a job. What steps will you take to help retain this bus service and/or provide alternative transit in Jeffersontown? Strengthening TARC in Jeffersontown goes hand in hand with addressing the traffic challenges we face. This critical service is used by thousands of folks living and working in Jeffersontown every day and is an important part of our economic development as a community. I already have good connections with several sitting Metro Council members, so on the council, I will work with my counterparts at Louisville Metro to explore increasing our city's contributions to the TARC fund and to explore other strategies to ensure routes are not further cut. This could look like prioritizing key routes that most directly impact those commuting for work.

Additionally, as part of the Bipartisan Infrastructure Law and other recent federal legislation, there are hundreds of millions of dollars available for cities to modernize and build resiliency within transit systems. I would explore how Jeffersontown and/or Louisville Metro government could access these funds, as well as alternative funding sources to ensure continued TARC routes in Jeffersontown. I will also look into options for partnering with local businesses that are particularly dependent on TARC and explore creating a sponsorship for Jeffersontown businesses to support a shuttle from TARC stations to business hubs to help employees get to work.

The Jeffersontown Gaslight Square is an iconic center for gatherings and commerce. What is your vision for downtown Jeffersontown?

I love all the city and chamber are already doing to bring the community to downtown Jeffersontown. These events provide wonderful activities for families to form memories and connect with others throughout the community. I have heard from fellow residents as I've been talking to them that they feel nervous when downtown with their kids, especially on days such as the farmer's market because of traffic and being concerned about their kids

running into traffic. I would look at options the council may already be considering to improve pedestrian safety downtown and create more bike parking spaces to encourage young people, families, and others to bike from their homes to downtown, park their bikes, and spend time walking around, shopping, and grabbing a bite to eat. I would also coordinate with the police department to address issues they have identified as well as solutions they may suggest.

I love the many local businesses we have downtown and I want to see more move into spaces as they are available. One of my favorite spots is the historic log cabin building downtown. I want to see what we can do to make it something people from across Louisville will visit. I think this is a great piece of our downtown that will feel unique and special if used well.

As a councilperson, what will you do to support employers and help grow the Jtown economy? I have already built relationships with many small businesses in Jeffersontown, including those located in the Bluegrass Commerce Park. When elected, I will send an email to each business in the Bluegrass Commerce Park, and all of Jeffersontown introducing myself and including my contact information. I would prioritize meeting with businesses as much as possible, and if they have issues that need to be resolved I would make sure to figure out how I could connect them with the Mayor and the council to find a solution. I may not know how to solve every issue businesses have, or even have the authority, but I'll be a connector and make sure our businesses get the resources and support they need.

As new businesses move to Jeffersontown, I will meet with them and ensure they have the support needed to make the move successfully. I would also work to ensure that we bring in businesses that better the community. One thing I would champion is helping people who live in Jeffersontown start businesses if they want to. Having people from the community own and run small businesses here will help us maintain our close-knit and connected community. One of my personal dreams is to own a small business and I would love nothing more than to help folks in Jeffersontown achieve that dream!

With the last two phases, the awarded contractor has agreed to a completion date, or penalties will be paid to the City. We hope to develop a committee to help promote our parks, arts program events, and entertainment with our new amphitheater set to open in Summer 2025.

As housing development grows in and around Jeffersontown, traffic in the area seems to be getting more congested. How will you address the growing traffic concerns and help to mitigate it?

People are seeing what a great community Jeffersontown is, which makes this a double-edged sword. Having more people a short distance from Gaslight Square will help with the foot traffic to our businesses and parks. We must keep public safety and security for all our residents and businesses. Most of our major arteries are maintained by the State or Metro, meaning we can only request traffic studies to yield results.

Last semester, a class from the University of Louisville used Jeffersontown's Historic Square for a project. The studies resulted in ideas to reopen back allies and connect Sprowl to Ruckriegel going behind Good Samaritan. This would help spread traffic to different entrance points to our main arteries.

Now we need a few more crosswalks on Watterson Trail and slow the car traffic crossing Taylorsville Road down.

You are correct; Bluegrass Commerce Park is more than vital to Jeffersontown. As I sat in the Chamber symposium of business leaders in J-Town, I noticed the City needs to promote some of the current incentive programs. We have the JOBS program, which is basically an occupational tax rebate on employee growth. We have a facade program that helps with beautification projects to the exterior of the facility. I have voted to reduce the building owner's J-town property tax rate 3 times since 2011. I recently voted to approve an innovative and strategic annexation necessary for our park's future growth.

What is your vision for our community?

Like most candidates I was born and raised in this community. I have raised my family, built a business, and served the community in a variety of ways. I have grown increasingly more concerned with the direction our city is going. We were debt free just a few years ago and now have borrowed \$10 million dollars with the likelihood of going after another \$5 million in the next year. As a taxpayer, both personally and with my company I can't help but question where we are going to get the money to pay the debt back. We seem to be trending in the wrong direction, and I believe I have the necessary skills to change our current trajectory. As a business owner, I am forced every day to make difficult decisions, manage a budget and create solutions for all parties involved. Difficult decisions are going to have to be made soon, and I believe I have the wisdom, courage and integrity to do so. I am not burdened by needing the compensation, insurance or power that seems to drive so many. I simply love J-town and am properly equipped to move our great city forward!

The development of the amphitheater has faced delays extending beyond the original intended timeline. How do you plan to expedite the completion of this project and ensure the successful launch of programming.

The amphitheater is a real black eye on the community. It was underfunded from the very beginning and has been poorly managed throughout the entire construction process. This project needs to be scrutinized at all levels. This is another example of difficult decisions that may need to be made. The amphitheater is a phased project, meaning we don't have to complete every phase right now. Our community leaders need to look long and hard at what options we have to try to get this to some level of completion so that it can be used, while accepting that we may not be able to bring this to its full potential at this time. Our city needs to operate within the financial constraints that we have, and borrowing more money only hurts the taxpayers of our community.

As housing development grows in and around Jeffersontown, traffic in the area seems to be getting more congested. How will you address the growing traffic concerns and help mitigate it? Traffic flow in the greater metro area is a growing concern and J-town is no different. There are a hundred ways to get in and out of J-town, but none are good. The challenges we have are that most of the main arteries dissecting our community are state roads, meaning we have very little jurisdiction to make many changes without their help. I would reach out to our state legislators and start working with them to see what improvements can be made. I would push to widen Waterson Trail from Bluegrass Parkway to Blankenbaker Pkwy. This creates another avenue for commerce to flow in and out of our industrial park. The north side of Watterson Trail at Blankenbaker will soon be getting another development most likely residential. Improving this portion of the road will allow motorist and trucks to come off of Blankenbaker thus improving the traffic flow on both streets. Coupled with that I would push for traffic light studies, especially on Watterson Trail and Ruckriegel Parkway to see what timing and sequencing can be done to the traffic lights to improve the flow. This is also true for Taylorsville Rd from I265 to Blankenbaker Pkwy. We already lost one major employer because of traffic challenges. For J-town to be a desirable destination for business to grow this issue must be seriously addressed.

Transportation is the number one reason someone loses a job. What steps will you take to help retain this bus service and / or provide alternative transit in Jeffersontown?

TARC's situation is dire. None of the three concepts that they are researching will be good for the city of J-town. The growth concept has a nearly zero chance of being obtainable as there is no funding available and nor is there any appetite for increased taxes. The ridership concept doesn't provide any service into the Bluegrass Commerce Park and the Coverage Concept would take so long that it would be untenable for most passengers. This is going to be especially challenging for the many businesses in the Bluegrass Commerce Park as so many businesses are struggling to get workers. My solution would be to work with TARC as well as the business leaders in the community to see if we can find a potential hub that can be set up in the area. From there create a shuttle loop that circulates through the city helping folks reach their destination. The city owns two shuttle buses commonly used for the Senior Citizen Center, maybe these can be used. I know of at least one company in the park that owns their own van, maybe there can be partnerships with the businesses to work out some kind of hub and spoke system to get people moved around our community. We must get creative and collaborative to solve this challenge.

The Jeffersontown Gaslight Square is an iconic center for gathering and commerce. What is your vision for downtown Jeffersontown?

Gaslight Square is on a great path. I would continue to promote the growth of shops, boutiques and restaurants to attract consumers into downtown especially at lunch time, evenings, and on the weekends. However, we also need to focus on attracting larger and / or destination types of businesses. These businesses create a larger tax base, which creates revenue, which is the lifeblood of any organization or government entity. The downtown district has so many things going for it, Farmers Market, great restaurants, and cool and unique shops which help facilitate the vision of Live, Work and Play for the community. Like everything we need to strike a balance. If we don't have revenue to support the growth and ongoing needs the progress we have made will be for naught.

The Bluegrass Commerce Park is a vital part of Jtown's economy. It is home to more than 1000 businesses including Baptist Health, ADP, KCC, and many others (large and small). As a councilperson, what will you do to support employers and help grow the Jtown economy?

As a business owner in the industrial park this is very important to me. These businesses are our golden goose. These businesses and their employees contribute mightily to the economy of our city. In fact, they do all the heavy lifting. But this sector is under attack in many ways. First, there are many other very viable options in the region to locate a large business. River Ridge, Riverport, and Eastpoint to name a few. These are newer and possibly more favorable locations to locate a business, so we need to get serious on how to help the current businesses in Bluegrass Commerce Park grow and thrive, as well as adding new businesses. We need to increase lighting and security to make the Park inviting for businesses and their employees to feel safe. Second, there is an attack on occupational tax. Many smaller communities are implementing occupational taxes on the workforce located in their community. The most recent example is Middletown. As these other communities work to enforce and grow their tax base, we are losing out on this revenue. The employees and businesses are educated and realize they don't have to pay the occupational tax if they weren't physically working within the various tax jurisdictions. We are already having to repay over half a million dollars back to these folks for taxes that shouldn't have been collected. We must work to shore this up, so this doesn't become a larger issue than it already has become

s housing development grows in and around Jeffersontown, traffic in the area seems to be getting more congested. How will you address the growing traffic concerns and help to mitigate it?

Jeffersontown's population density has grown to 2,900 people per square mile, compared to Louisville's 1,400 people per square mile. The increase, while beneficial, is putting pressure on major roads like Hurstbourne Lane, Taylorsville Road and Watterson Trail. To address this, we should take the following steps:

- Require future developers to submit traffic impact plans for their projects.
- Partner with the Kentuckiana Regional Planning & Development Agency (KIPDA), which is preparing a report on parking and transportation in the Historic Gaslight Square District. The city should carefully consider and implement its recommendations.
- Create an access management plan that improves how vehicles enter neighborhoods and businesses, including the potential for roundabouts.
- Prioritize infrastructure upgrades, such as widening roads and adding turn lanes at key intersections.

These measures will help manage traffic congestion while supporting growth and maintaining quality of life for residents.

TARC is currently facing a serious financial crisis which could threaten transit services in Jeffersontown. Changes to TARC services in Jtown impacts both residents and employers. Transportation is the number one reason someone loses a job. What steps will you take to help retain this bus service and/or provide alternative transit in Jeffersontown?

TARC is grappling with a financial crisis, with a projected \$30 million deficit by mid-2026. To address this, TARC is evaluating three options, one of which would enhance the transit system if additional funding were secured.

Without new funding, the other two options will involve significant service cuts. One option could eliminate TARC routes in Jeffersontown, while the other would reduce the frequency of already limited stops. Neither is ideal.

A key issue is TARC's primary funding source, an occupational tax that has remained unchanged since 1974.

Jeffersontown leaders must advocate for increased funding, work with other local leaders to secure additional revenue streams and promote a revision of the occupational tax structure that supports TARC.

If additional funding is not secured and critical routes in Jeffersontown are cut, we should explore financial partnerships with TARC and Louisville metro to maintain services.

TARC has already begun discussions on a long-term funding and service improvement strategy through its "TARC Tomorrow" initiative, which aims to identify new revenue sources and redesign the bus network to better meet community needs. It's crucial that our city officials actively participate in these discussions to ensure Jeffersontown's needs are addressed moving forward.

The Jeffersontown Gaslight Square is an iconic center for gatherings and commerce. What is your vision for downtown Jeffersontown?

Every year the Gaslight Festival brings in an estimated 170,000+ people to Downtown Jeffersontown. During this time our community is buzzing, businesses can bring in new customers and we are in the local spotlight. This type of energy can continue in the Gaslight District throughout the full calendar year. For our community to operate at the optimal level, we need Downtown Jeffersontown to be a vibrant hub. To make this happen we need to:

- Continue to invest in streetscape improvements to create a pedestrian-friendly environment.
- Improve connectivity between Gaslight Square and surrounding neighborhoods for easier access.
 Attract local and independent restaurants to cater to diverse tastes.
- Encourage unique retail shops to enhance the shopping experience. Host community events, festivals, and performances in Gaslight Square and the Amphitheatre to showcase local talent.
- Move the Jeffersontown Museum to the Historic district. Use an iconic building like the log cabin on Watterson Trail for new more visible location.

By focusing on these areas and collaborating with residents and businesses, downtown Jeffersontown can evolve into a vibrant, livable center that serves as a source of pride for the entire $_{23}$
